Monmouth County Bridge W-43

This presentation will discuss the Monmouth County Bridge W-43 which is a dual leaf bascule span movable bridge which crosses the Shark River, by providing an overview of the design method utilized to successfully underpin the trunnion and pinion supports to serve as a case study and template for similar repairs. The presentation also provides some of the challenges encountered during construction and identifies the original causation of the repair.

At 339 feet long, the bridge is owned and operated by Monmouth County and serves as a vital link between the boroughs of Avon-by-the-Sea and Belmar, two popular summer tourist destinations along the Jersey Shore. Constructed originally in 1936, W-43 is now in its 84th year of service and has been the subject of several rehabilitation projects to maintain its serviceability to the motoring public. The bridge is also located at the mouth of the Shark River Inlet, making it a critical structure for navigable traffic.
